Professional Development. 4C offers high quality courses for teachers, directors and family child care providers. In 2009 4C enrolled more than 28,666 participants in 1,681 trainings, which include a tiered system of learning opportunities, meeting diverse needs of teachers and providers. Partnerships with area colleges enable 4C to offer college credit. 4C also provides coaching, technical assistance and training for quality-rating systems in Ohio and Kentucky; 2,772 technical assistance visits were made to centers and family child care homes in 2009. 4C also provides a range of specialized services including infant-toddler specialists, school-age specialists and specialists helping program achieve star ratings under Ohio (83 programs assisted and 23 moved up to a higher rating) and Kentucky (20 programs assisted)

4b (Code:) (Expenses \$ 636,910. including grants of \$ 143.) (Revenue \$ 55,859.) Parent Services. 4C provides free consumer education and child care referrals to parents and grandparents using a comprehensive listing of licensed centers and preschool programs, family child care providers, Head Start programs and school-age child care options. In 2009, 4C served 7,633 families with services including child care searches, referrals to community resources, and educational information on selecting quality care. 4C also reaches out to parents who care for children at home as well as informal caregivers (i.e., family, friends and neighbors) to raise their awareness about brain development (90 percent of which takes place before a child reaches kindergarten) and what can be done to ensure that each child has the kind of stimulating environment that helps a young brain grow. 4C reached 1,508 families in

4c (Code:) (Expenses \$ 2,535,819. including grants of \$ 13,855.) (Revenue \$ 28,807.) Family Child Care Services. Supporting home-based child care businesses and recruiting new providers is critical to meeting the needs of our community. Family child care is the most affordable type of care and one that best meets the needs of parents with non-traditional hours. Besides trainings especially developed for family child care providers, 4C offers a Provider Insurance Program with a range of personal benefit programs aimed at family child care providers and small child care centers. In 2009 4C recruited and helped establish 123 family child care providers. As the local sponsor for the childhood component of Ohio's Child and Adult Care Food Program, 4C helped 2,769 children receive more nutritious meals daily.
