The **Ohio Professional Registry** is a centralized information system for early childhood and afterschool professionals. Individuals track professional growth and development and are recognized for their experience, education, credentials and training.

Once information is entered into the Ohio Professional Registry and documentation uploaded for verification to the Ohio Child Care Resource & Referral Association (OCCRRA), a career pathway level (CPL) is awarded.

**PD Track** is the online tool that allows professionals to search and register for statewide trainings delivered by multiple agencies. Trainings taken through PD Track are automatically linked to a profile on the Registry.

The **Organizational Dashboard** allows you to access employee/staff registry information through your own registry profile.
